- <u>Website:</u> The library website went temporarily offline when we discovered our domain name expired. Various problems were discovered. Recommended that the board accept the quote presented by RockWeb Systems Inc. to repair and upgrade the website.
- <u>Personnel:</u> Cheryl Ciaramella has accepted the position of Senior Library Clerk, Technical Services
- <u>New York Construction Aid Grant:</u> The Mount Kisco Public Library has been notified that it will receive a grant to expand the geothermal system and replace the front doors
